3. A copy of the deceased securities holder's death certificate, certified true by the estate administrator.
4. The original securities certificate(s), the back of such certificate(s)

Individual person - Other Nationalities	<ul style="list-style-type: none"> - The <u>original and a copy</u> of the signatory's alien identity card or passport, certified true with an original signature (the document must not be expired). * <u>If the original passport cannot be shown or the documents are being submitted by registered mail,</u> - The copy of the passport has to been certified by a notary public, and both the copy and notary public stamp certified by the Thai embassy or consulate. <li style="text-align: center;"><> The certified documents valid within 1 year before being submitted registration form to RICH.
