- 2. A copy of the Thai court decree appointing the estate administrator and certificate final judgment, certified true by the estate administrator, issued within 1 year before submitted to RICH.
- 3. A copy of the deceased securities holder's death certificate, certified true by the estate administrator.
- 4. The original securities certificate(s), the back of such certificate(s)

Transferor Box : signed by the Estate Administrator

Transferee Box : signed by the heir

Note: In case of the Estate Administrator is the heir must sign in both Transferor and Transferee boxes.

5. Identification documents of Estate Administrator and Transferee, according to the type of person.
