- 2. Securities certificate

- Police Report specifying the following details, (which can be obtained from RICH)
  - The securities holder's name Securities certificate number Amount of Share
     (Any copy of Police Report must be certified as true by the police officer.)
- Identification documents of securities holder and grantee (if any), according to the type of person.

- 1) Application for amending securities holder records.
- 2) The document showing a change of name or surname or marriage or divorce certificate as the case may be.
- 4. In case of the securities holder has deceased, attach the following documents certified true with an original signature of the estate administrator as follow:
  - 1) A copy of the court decree appointing the administrator of the inherited estate and certificate final judgment, certified within 1 year before being submitted to RICH.

	seal of the notary public or any other authority which performed the act under (1).
