4. Identification documents of the transferor, the transferee and the grantee (If any), according to the type of person.

Individual Person - Thai Nationality	<p>- The <u>original and a copy</u> of the signatory's Thai national I.D. card, certified true with an original signature (document must not be expired).</p> <p>* <u>If the original I.D. card cannot be shown or the documents are being submitted by registered mail.</u></p> <p><u>Please attached</u> the copy of the Thai national I.D. card has to been certified true with an original signature and the original of the document issued and certified by the sub-district or district office to use instead of the <u>original</u> Thai national I.D. card (validity 90 days from the issuing date).</p>
Individual Person - Other Nationalities	<p>- The <u>original and a copy</u> of the signatory's alien identify card of passport, certified true with an original signature (document must not be expired).</p> <p>* <u>If the original passport cannot be shown or the documents are being submitted by registered mail.</u></p> <p>- The copy of the passport has to been certified by a notary public, and both the copy and notary public stamp certified by the Thai embassy or consulate. The certified documents valid within 1 year before being submitted registration form to RICH.</p>
Juristic Person - Thai Nationality	<p>1. A Copy of the juristic person certificate issued by the Ministry of Commerce valid within 1 year, with the original signatures of directors authorized to represent the company or their representatives, according to such company's conditions.</p> <p>2. A copy of the national I.D. card/alien identity card/passport of directors who are authorized to represent the company, certified true with original signatures (document must not be expired).</p>
Juristic Person - Other Nationalities	<p>1. A copy of the company's registration certificate issued by the regulating government agency which such juristic person be located.</p> <p>2. A copy of the juristic person's affidavit of incorporation showing directors authorized to bind the company and conditions relating thereto, showing the company's headquarters location and authority of the signatory. This affidavit must be issued by an authorized official of the juristic person or the government agency having jurisdiction over the juristic person.</p> <p>3. A copy of the passport or other official identity document of each authorized director signing this document, certified true with an original signature.</p> <p><u>In case of documents has been prepared or certified in other countries, must be processed as follow :</u></p> <p>(1) The notary public or any competent authority in the country where such documents were prepared or certified correct, shall certify the signature of the person who prepared such documents, or who certified the accuracy of such documents.</p> <p>(2) An official of the Thai Embassy or Thai Consulate in the country where such documents were prepared or certified correct, shall certify the signature and the seal of the notary public or any other authority which performed the act under (1).</p> <p>- The certified documents valid within 1 year before being submitted registration form to RICH.</p> <p>- Documents prepared in a foreign language other than English must be translated at least in English.</p>
